

Dear Parents, Carers, Guardians,

As we approach the end of a fantastic summer term, I wanted to take the opportunity to thank you for all of your support and to update/remind all families and students of a few key aspects. The vast majority of the information below is not new and we will be working with all students in the first week back to ensure that they are fully aware of our expectations.

Mobile phones

Broadoak Academy is a mobile phone free site. Students are permitted to bring mobile phones with them for safeguarding purposes for the journey to and from school. However, for the duration of their time of site, all phones must be on silent and in school bags. Any student who is found to be using their phone will be asked to hand it in and to collect it from the house team at the end of the day. Any student who is referred to our workspace/Branch area will be asked to hand in their phone and collect it from this space at the end of the day. We ask that you do not try to contact students during the school day via their mobile phones, if you require a message to be relayed to a student then please call our reception on 01934422000.

Uniform and ties

All students should return to the academy in full uniform. Please ensure all uniform items are named, this way we can get them back to the students to promptly.

Bag, bottle and equipped to learn

As we prepare our students for a life of learning and work, it is vitally important that they are correctly equipped to learn. Every student should attend the academy with a school bag in which they can store their mobile phone, water bottle, pencil case (with equipment) and any resources given to them by their subject teachers. We will be supporting students to ensure that they are correctly prepared and will make contact with families where support is required.

Use of toilets during the academy day

We will always ensure that toilets are available for students with medical conditions during the academy day, however, based on recent research as well as on safeguarding grounds we will be leaving toilets which are in supervised areas only

available for use during lesson time. It is vital that we ensure our students safety at all times, especially if they use toilets due to a medical need. Students will not be permitted to leave a lesson to use a toilet unless they have a toilet pass based on medical advice or if considered an emergency at the discretion of the class teacher. In this case, they will use the toilets as described earlier – students have been told and will be reminded which toilets this refers to.

Allocated toilets will be available as usual for lunchtime and between the first and second bell to allow students to use these facilities before heading to their learning.

Attendance/Punctuality

As you may be aware, recent guidance relating to attendance has been released to schools. The most significant impact of this impacts the closing of morning registers. As you will be aware, our morning registration period starts at 8:45am, however the morning register will no close at 9:15am, meaning that any student arriving after this time will be recorded as an unauthorised absence for that session. 10 recorded unauthorised absences (sessions not days) within a specific time frame could result in a fixed penalty notice being issued.

We would like to work with you and your child/children to avoid this, so please contact your child's tutor or house team should there be any issues with punctuality or attendance.
